RESOLUTION ACCEPTING A GRANT FROM THE CALIFORNIA OFFICE OF EMERGENCY SERVICES GRANT AWARD XC20030290 FOR THE NEVADA COUNTY VICTIM SERVICES PROGRAM IN THE AMOUNT OF \$148,026.00 FOR THE PERIOD OF JANUARY 1, 2021 TO DECEMBER 31, 2021 AND AUTHORIZING THE DISTRICT ATTORNEY TO EXECUTE THE AGREEMENT

WHEREAS, the California Office of Emergency Services (Cal OES) has awarded the County of Nevada District Attorney's Office Federal Victim of Crime Act (VOCA) Grant funds; and

WHEREAS, the Cal OES grant award is comprised of Federal VOCA funds in the amount of \$148,026.00.00, and have been made available for the grant period of January 1, 2021 to December 31, 2021; and

WHEREAS, these funds will be used to provide comprehensive services to victims and witnesses of crime as specified in the California Penal Code Sections 13835-13835.5.

NOW, THEREFORE, BE IT FURTHER RESOLVED the Board of Supervisors of the County of Nevada, State of California, accepts the California Office of Emergency Services grant for Nevada County Victim Services Program in the amount of \$148,026, for the grant period of January 1, 2021 to December 31, 2021, which shall be deposited into District Attorney Revenue Account 0101 50608 203 1000 447700.
