I recently heard that a member of the Board of Supervisors will introduce a Healthy Communities' resolution to open up Nevada County quickly. My wife and I think that would be a **terrible mistake**. Public policy, especially regarding public safety, should be based on facts and science and properly balance the needs of public safety with the needs of the local economy.

Facts:

- (1) Nevada County is still in purple status. The state guidelines require that counties enter red status before starting to open up.
- (2) New and dangerous variants of Covid 19 are starting to enter California. They are anticipated to become the dominant variants by mid spring. These variants spread much more quickly than the existing variants and are more dangerous, so opening now will put our citizens at greater risk. We do not even know yet whether the current vaccines will protect against them
- (3) CDC Guidelines, which are based on science, indicate that masks should continue to be mandated and social distancing continued until at least 70% to 80% of the population has been vaccinated. Only a small parentage of Nevada County citizens has been vaccinated because of the unavailability of vaccines. Because of our own age and getting our health care through the UC Davis Medical System, my wife and I have been fortunate enough to receive our two Pfizer vaccine shots. However, on medical advice, we will continue to wear masks, exercise social distancing, and avoid unnecessary trips because we are potential carriers of Covid 19 and do not want to harm our fellow citizens.

We care greatly about our local businesses and have continued to support them during the pandemic, if necessary, by having others shop for us. We have supported restaurants by buying many of our meals through take out. However, if we open enclosed spaces, such as restaurants, too quickly, we will greatly increase the risk. The science has showed that enclosed spaces that lack high quality air filtering systems pose the greatest public health risk, even with masks. Local restaurants do not have and cannot afford those kinds of systems.

We know that loud and angry contingent of Nevada County residents showed up at the last Board meeting and attacked you because the County's public safety policies. We understand those kinds of attacks are difficult. Most of those people have unfortunately been convinced not to trust the science, but they are wrong. You know better. They also do NOT represent the majority of Nevada County citizens. The rest of us are counting on you to keep us safe. Please do so!!

I did send this directly to the 5 Bd members and the County CAO.

I moved to Nevada City two years ago after retiring from 42 years in local government. I moved here for the energy of downtown Nevada City and Grass Valley, the arts community, Victorian Christmas, Wild & Scenic Film Festival, the independent bookstores, the quality restaurants and the small business vibe where often you meet the owner of the establishment.

Of course like everything else, many of these things have been significantly curtailed due to the pandemic and our society's attempt to limit impacts through masks, distancing, shutdowns and other measures.

I know how much work goes on behind the scenes - by government - to respond to emergencies and protect public health and safety. Balancing priorities in a complex environment is not easy - what is easy is to sit back -without responsibility - and criticize those who are working overtime to do whats best for the common good.

I cannot imagine what its like for restaurant and business owners trying to make a living in the midst of changing rules, varying levels of shutdown, and our other challenges.

I also believe that the rules established by the State, even in their imperfection, are intended for our collective protection. Thus - it is really troubling to see the number of restaurants who are flaunting safe practices by serving indoors. I love our restaurants, I eat outside or take out, or buy expensive gift certificates for later use whenever I can. But the flagrant violation of the prohibition on indoor frankly amazes me.

What I find most troubling is that - while large diverse hard to manage urban areas like San Francisco, or highly visited areas like Napa County - have moved to the Red Tier - enabling the looser restrictions that the restaurants and others so desire.

Frankly I can't help but wonder if our inability to move into the red (rather than lingering in purple) is directly related - to some degree - to the number of establishments who provide indoor eating.

Yes I understand most of California's population is in the purple tier - but 5 of the Bay Areas counties have advanced to the red tier. I would argue that with strict compliance and more 'we're in this together' behavior - Nevada County could be doing better, perhaps even open to where the 'free Nevada County' group desires. To me its ironic that the very people who want to open - are essentially preventing that by their behavior.

One note - I visited Mendocino the other day - I didnt see one nose or mouth - even among people walking alone in the headlands. There was no indoor eating at any restaurant. Compliance is possible. Not easy, but possible.

Again - I want to emphasize - whenever I drive or walk by the many establishments with indoor eating - I cannot help but think that contributes to our lingering in the purple zone.

My daughter lives in LA county, her boyfriend owns a restaurant that was closed both indoor and out for weeks. It was very difficult for him and them. When she came here she was shocked to see the number of places allowing indoor eating. Her comment was it must be nice to violate the rules, maybe spread the virus, and negatively impact those who are in compliance.

I understand the feeling of disparate treatment by restaurant owners when compared to other businesses - but sitting inside with wait staff going from table to table - is not a safe activity. There is not question the virus spread in that context.

Bottom line - I am deeply disturbed by the flagrant violation of policies designed for our collective protection - and - I'm disturbed that the restaurants who are complying are basically at a competitive disadvantage for doing whats best for the community.

Of course restaurants are not the only issue - perhaps on balance maybe even a minor one. Also part of the challenge are those who refuse to wear masks indoors or in public spaces.

Again - they are not solely responsible for the virus - but such behavior is responsible for its spread beyond that which we could control with our collective concern for each other.

I love my County but I am deeply disappointed. I just wonder if I violated rules to that extent would I be allowed to flaunt the standards without consequence.




