**SUBJECT:** Resolution approving execution of Amendment No. 1 to the

renewal contract with Nevada County Superintendent of Schools (NCSOS) for the provision of Transitional Housing

Program Plus (THP+), for eligible foster care youth increasing the maximum contract amount to \$313.915

increasing the maximum contract amount to \$313,915 for FY 20/21 (an increase of \$13,915), revising Exhibit "A" Schedule of Services to reflect a change to include the Housing Navigator Program (HNP) and the Transitional Housing Program (THP), and revising Exhibit "B" Schedule

of Charges and Payments to reflect the increase in the

maximum Contract price. (RES 19-271)

**RECOMMENDATION:** Approve the attached Resolution.

**FUNDING:** Services are funded by Child Welfare 2011 Realignment. Services are within the Department's FY 2020/21 budget and there are no county general fund dollars required in the Agreement.

## **BACKGROUND:**

Per Resolution 19-271, the Nevada County Board of Supervisors approved execution of the of renewal contract with Nevada County Superintendent of Schools (NCSOS) for the provision of Transitional Housing Program Plus (THP+). Under this Agreement, Nevada County Superintendent of Schools will continue to provide services related to THP+, a Transitional Housing Placement Program for eligible foster youth, 18-25, who have emancipated from the Child Welfare System. The goal of the program is to provide a safe living environment while helping youth to learn life skills and achieve self-sufficiency upon leaving the foster care support system.

Participants may live alone or with roommates in apartments or in single-family dwellings with regular support provided by THP+ agency staff and ILP (Independent Living Program) Coordinators. Contracted support services include regular visits to the participants' residences, educational guidance, employment counseling, instruction and

monitoring of budgeting and household expenses and assistance in reaching their goals as outlined in the participants' Transitional Independent Living Plan (TILP). High quality, consistent supportive services targeted to meet the needs of individual youth are essential ingredients to a successful THP+ Program. Youth may live in either permanent or transitional housing units depending on the individual participant's needs and abilities. The program provides financial assistance for youth to secure housing, employment, education, transportation and other miscellaneous assistance to help the youth secure a permanent living situation while building the skills and resources necessary to become independent adults.

The Contractor will work with each participant to individually tailor the program to best meet their particular needs and promote transitioning to self-sufficiency.

The Department of Housing and Community Development (HCD) allocated funding to counties for the support of the Housing Navigator Program (HNP) and the THP to help young adults aged 18 years and up to 25 years secure and maintain housing, with priority given to young adults from the foster care system.

It is recommended that the Board approve this Amendment as the services the Contractor will be providing will help young adults secure and maintain housing and transition to adulthood.
