OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING EDUCATIONAL INTERNSHIP PROGRAM WHICH PROVIDES A MAXIMUM \$599 STIPEND PER STUDENT PER CALENDAR YEAR

WHEREAS, the Nevada County Human Resources Department has committed to supporting economic development in the County through internships which help train local youth and young adults; and

WHEREAS, the Human Resources Department has worked with local high schools and community colleges in Western and Eastern County to develop an opportunity for students to earn school credit while serving an internship; and

WHEREAS, student interns would gain valuable experience, training, and insight into local government while serving in the internship; and

WHEREAS, County departments which host an intern would be permitted to provide a stipend of up to \$599 per calendar year.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that an Educational Internship Program be adopted with the following guidelines:

- Two standard assignment lengths are six weeks and fifteen weeks.
 - The six-week internship would be offered during summer months.
 - o The fifteen-week internship would be offered during a school's semester term.
- The standard six-week internship requires 15-20 hours per week of the student's time. The standard fifteen-week assignment requires 5-8 hours per week.
- The standard six-week or fifteen-week assignment would offer a \$599 stipend.
- In order to enhance student success, some internship assignments may vary from the standard six-week or fifteen-week duration. For example:
 - A two-semester internship may be developed and offered if the subject matter and learning component require two semesters.
 - If a County department offered a two-semester internship of fifteen weeks in one semester and fifteen weeks in the next semester, and the student devoted 3-5 hours per week in the internship, then the department may pay the student \$298 per semester.
 - Internship opportunities may vary from the standard six-week or fifteenweek duration and stipend amounts will vary accordingly.

- An educational internship student may earn a maximum of \$599 under this program per calendar year.
- Students may participate in the program over successive calendar years so long as they are sponsored by an educational partner (high school/college) with Nevada County and have a signed educational agreement on file.
