**SUBJECT:** Resolution approving Amendment No. 5 incorporating Modifications No. 009 and 010 to the Cooperative Law Enforcement Agreement #17-LE-1105-1360-018 between the Nevada County Sheriff's Office and the U.S.D.A. Forest Service, Tahoe National Forest adopting the 2021 Annual Operating and Financial Plan related to Campground Patrol and Controlled Substances

**RECOMMENDATION:** Adopt Resolution

**FUNDING:** Funding in the amount of \$24,000, is for October 1, 2020 to September 30, 2021 and impacts the Sheriff's Operations budget. Operational expenses will be reimbursed by the U.S. Forest Service. This is not a mandatory service.

**BACKGROUND:** The County of Nevada approved a five (5) year Cooperative Law Enforcement Agreement ("Agreement") with the US Forest Service on April 11, 2017, Resolution 17-154, to provide campground patrol primarily during the summer months when visitor activity to the county and forest lands is at its peak and surveillance of illegal narcotics activity. An approved Annual Operating and Financial Plan is required for each year during the term of the Agreement. This will be the last year of the five (5) year agreement.

On April 24, 2018, Resolution 18-153 approved an amendment to the Agreement to provide for the Federal FY 2018 Annual Operating and Financial Plan. On May 28, 2019 Resolution 19-207 approved Amendment #2, Modification No.005, to provide for the Federal FY 2019 Annual Operating and Financial plan for Exhibit A, Campground Patrol. On August 13, 2019 Resolution 19-440 approved Amendment #3, Modification No. 006, to provide for Federal FY 2019 Annual Operating and Financial Plan for Exhibit B, Controlled Substance. On August 11, 2020 Resolution 20-359 approved Amendment #4, Modifications 007 and 008 to provide for Federal FY 2020 Annual

Operating and Financial Plan for Exhibit B, Controlled Substance and Exhibit A, Campground patrol. This Resolution is to approve the Fifth amendment to the Agreement originally authorized by Resolution 17-154 and modify Exhibits A (Modification No. 010) and B (Modification No.009 by establishing the amount of reimbursement for Federal FY 2021 at \$12,000 each for a total amount of \$24,000.

The operational period for reimbursement is from October 1, 2020 to September 30, 2021.
