OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION TO APPROVE THE COLLECTION OF PARCEL CHARGES AND SPECIAL TAXES FOR SERVICES IN COUNTY SERVICE AREAS AND PERMANENT ROAD DIVISIONS FOR FISCAL YEAR 2021/22

WHEREAS, the Director of the Department of Public Works has prepared the Parcel Charges and Special Taxes in County Service Areas and Permanent Road Divisions; and

WHEREAS, the Parcel Charges and Special Taxes are in conformance with Proposition 218, as approved by the voters in November 1996.

NOW, THEREFORE, BE IT HEREBY RESOLVED that the Nevada County Board of Supervisors authorizes the collection of parcel charges and special taxes for Fiscal Year 2021/22

Authorizes an annual adjustment to the road maintenance charges beginning in Fiscal Year 2020/21 and continuing indefinitely for each fiscal year thereafter as set forth in the *San Francisco Area Consumer Price Index, as of January 1st* (posted as December month ending data) of each calendar year, not to exceed 5% per annum.

AND BE IT FURTHER RESOLVED that the Nevada County Board of Supervisors authorizes the Auditor/Controller to collect fees and charges in regard to the administration of these charges in accordance with Resolution No. 15-278.
