

## **RESOLUTION No.**

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING A STANDARD PUBLIC WORKS CONTRACT BETWEEN THE COUNTY OF NEVADA AND BOCKMON & WOODY ELECTRIC CO., INC., FOR THE NEVADA COUNTY ERIC ROOD ADMINISTRATIVE CENTER GENERATOR REPLACEMENT PROJECT IN THE AMOUNT OF \$435,000 PLUS A CONTINGENCY OF \$43,500 FOR A TOTAL CONTRACT AMOUNT OF \$478,500, AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE THE CONTRACT, AND AMENDING THE FISCAL YEAR 2020-21 CAPITAL FACILITIES BUDGET (4/5 AFFIRMATIVE VOTE REQUIRED)

WHEREAS, the two existing electrical standby generators can only service approximately 40% of the Eric Rood Administrative Center (ERAC) during a power outage causing department closures and public service interruptions; and

WHEREAS, a new Kohler 500 kw standby generator has been purchased to replace the two existing generators at the ERAC and supply 100% of the power during an outage is ready to install; and

WHEREAS, bid construction documents were prepared and approved through Resolution 21-082 for the project known as the Nevada County Eric Rood Administrative Center Generator Replacement; and

WHEREAS, sealed bids were solicited and one (1) timely bid for this project was received and opened on May 5, 2021; and

WHEREAS, the responsive and responsible bid was from Bockmon & Woody Electric Co., Inc., of Stockton, California, in the amount of \$435,000; and

WHEREAS, the contract will be in the bid amount of \$435,000 plus a 10% contingency of \$43,500 for a maximum contract amount of \$478,500; and

WHEREAS, funding for this project will be paid out of the Fiscal Year 2020-21 Capital Facilities budget.

NOW, THEREFORE, BE IT RESOLVED that the Nevada County Board of Supervisors hereby directs that:

 The contract for the Nevada County Eric Rood Administrative Center Generator Replacement Project located at the Eric Rood Administrative Center, 950 Maidu Avenue, Nevada City, California, in the amount of \$435,000 plus a contingency of \$43,500 for a total contract amount of \$478,500 be awarded to Bockmon & Woody Electric Co., Inc., 1528 El Pinal Drive, PO Box 1018, Stockton, CA, 95201.

- 2. The Board approves and the Board Chair is authorized to execute a Nevada County standard public works contract on behalf Nevada County with Bockmon & Woody Electric Co., Inc., upon receipt, approval, and acceptance of the certificates of insurance and bonds.
- 3. The Purchasing Agent is authorized to execute change orders pursuant to Article IX of the Contract, up to the total contingency amount of \$43,500.
- 4. Contractor shall commence the work 10 days after mailing of written notice to proceed by County. All work shall be completed and ready for acceptance on or before 180 days of the mailing of the Notice to Proceed.
- 5. The Auditor-Controller is directed to release \$478,500 from the Unassigned Fund Balance of the General Fund and to amend the Fiscal Year 2020-21 Capital Facilities budget as follows:
