2021 Fire Season Briefing Nevada County Board of Supervisors

Reflecting on the Statewide 2020 Fire Season



- 9,917 SRA wildland fires in 2020
- 4,257,863 acres were burned.
- 10,488 Structures were destroyed
- **33** Fatalities directly related to fires
- 2020 was the worst recorded fire season in California History



Nevada Yuba Placer Unit (NEU) 2020 Fire Season



- 875,000 acres of SRA Direct Protection area in NEU
- 990 Wildland Fires in NEU in 2020
- **125** Wildland Fires in Nevada County totaling **780** acres
- Willow and Jones Fires / resource drawdown were 2020 challenges
- **95%** of fires at **10** acres or less goal is CAL FIRE state wide goal
- 95.8% initial attack success



2021 Fire Season and Forecasted Conditions



- Minimal snowpack as of June 1st in the Sierra Mountains
- No additional rains predicted
- Grass loading is average and cured
- Potential for monsoonal flow with potential lightning
- Predicted **very high potential** for large fire growth at mid to higher elevations
- Fire spread predictions are approximately 3 months ahead of normal



2021 Fire Season Update and Preparedness



- Burn suspension May 24th
- Fire Season declared May 24th
- Peak Staffing in NEU June 1st
- 411 State funded personnel
 - ✓ 27 State staffed Engines
 - ✓ **5** Type I Hand Crews
 - ✓ 4 Dozer Units
 - ✓ 2 Air Tankers and 1 Air attack



2021 Fire Season Update and Preparedness



- Hand crew strength down approximately 80 crews statewide
- Adding additional dozers and Firefighter Handcrews Statewide
- CNG Crew through end of 2021
- 9 of 13 S-70i Blackhawks in service for fire season 2021
- 23 Airtankers in service and C-130 program on track for 2022



2020 / 2021 Fuel Reduction Efforts



- North Fork Shaded Fuel Break Phase 1 is complete – 900 acres
- Ponderosa West Defense Zone Phase 1 is complete – 950 acres
- 820 additional acres of private land have been treated through 2020
- Over **800 hazard** piles burned in 2020/2021. Prescribed fire hampered by dry winter of 2020



2020 / 2021 Fuel Reduction - Eastside



- Year round staffing at Station 50
- **712** hazard piles burned on SRA in Tahoe Region
- 58 acres treated in high hazard areas
- 97 hazard trees felled in WUI areas
- 4th Fire Dozer added to Unit for pre positioning on eastside during red flag events

Welcome to the District

- 4 District staffed fire stations and 1 joint staffed City of Grass Valley fire station
- 143 square miles of jurisdictional responsibility
- Full-time staffed Department of Fire Prevention
- Over 3500 calls for service on an annual basis







The 2020 California Fire Season

- 22 Responses out of County
- 18,594 Personnel hours assigned to Master Mutual Aid
- 1 Residential structure was destroyed in NCC's jurisdiction during the Jones Fire







The 2021 California Fire Season Outlook

- 9 additional NCC Seasonal Firefighters
- Numerous NCC personnel certified to fulfill command and general staff positions
- On-going relationships with our allied agencies, which makes our operations seamless
- Shortfall Limited number of personnel based upon NFPA 1710 recommendations
- Concerns Depth of coverage during a significant incident within the County







"Rescue 84" – The New Edition

- 2020 Ford F-550 4-wheel drive, with 150 gallons of water
- All-Risk response capabilities
- 60% less cost than a 4-wheel drive fire engine
- Capable of accessing remote areas
- 50% less cost per mile than a 4-wheel drive engine
