OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION APPROVING CONTRACT AMENDMENT NO. 4 WITH WEST COAST ARBORISTS, INC., FOR TREE TRIMMING AND REMOVAL SERVICES

WHEREAS, the Nevada County Board of Supervisors (Board) approved Resolution 17-529 approving a contract with West Coast Arborists, Inc., (WCA) for tree trimming and removal services with the ability to execute four (4) additional annual renewals beginning July 1, 2019; and

WHEREAS, the Board approved Resolution 19-281 approving Amendment No. 1 to the contract for \$150,000 effective July 1, 2019 through June 30, 2020; and

WHEREAS, the Board approved Resolution 19-387 approving Amendment No. 2 to allow for an updated Exhibit B: Schedule of Charges and Payments to allow for increases in the California Department of Industrial Relations pre-determined wages; and


WHEREAS, the Board approved Resolution 20-258 approving Amendment No. 3 to the contract for \$150,000 effective July 1, 2020 through June 30, 2021; and

WHEREAS, the Department recommends approving Amendment No. 4 with West Coast Arborists Inc., for an additional one-year term of July 1, 2021 through June 30, 2022, with a not-to-exceed contract amount of \$150,000; and

WHEREAS, fiscal year 21/22 has sufficient budget in 1114-30107-703-521520 to encumber the contract.

1. Approves Amendment No. 4 to the contract and authorizes the Chair of the Board of Supervisors to execute the Amendment between the County of Nevada and West Coast Arborists, Inc., for tree trimming and removal services.
