RESOLUTION 2021-32

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF TRUCKEE
AUTHORIZING THE CONTINUATION OF
THE NEVADA COUNTY SERVICE AUTHORITY FOR
THE ABATEMENT OF ABANDONED VEHICLES AND
THE COLLECTION OF A VEHICLE REGISTRATION FEE FOR TEN YEARS**

WHEREAS, Section 22710 of the California Vehicle Code authorizes the establishment of a service authority for the abatement of abandoned vehicles in a county, as well as the collection of a \$1 vehicle registration fee, if the county board of supervisors and a majority of cities having a majority of the county's incorporated population have adopted resolutions providing for the establishment of the authority and collection of the fee; and

WHEREAS, the County of Nevada, the Cities of Grass Valley and Nevada City, and Town of Truckee have previously entered into a joint powers agreement to establish such a service authority; and

WHEREAS, pursuant to California Vehicle Code Sections 9250.7 and 22710, the service authority adopted a \$1 vehicle registration fee on vehicles registered to an owner with an address in Nevada County; and

WHEREAS, the current \$1 is set to expire on April 30, 2022, but pursuant to California Vehicle Code Section 9250.7, the fee may be extended in increments of 10 years if the County Board of Supervisors and a majority of cities having a majority of the incorporated population within the County adopt resolutions providing for the continuation of the fee; and

WHEREAS, the Town Council has been informed that the Nevada County Board of Supervisors and the city councils of Grass Valley and Nevada City either have adopted resolutions providing for the continuation of the existing joint powers agreement for vehicle abatement and the \$1 abandoned vehicle abatement program fee until April 30, 2032, or intend to do so in the near future; and

WHEREAS, the revenue received from the \$1 fee is used solely for the abatement, removal and disposal of vehicles within Nevada County, the Cities of Grass Valley and Nevada City, and the Town of Truckee; and

WHEREAS, having funds available to pay for the removal and proper disposal of abandoned vehicles helps keep Truckee clean and safe by preventing an accumulation of abandoned vehicles;

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE TOWN COUNCIL OF THE
TOWN OF TRUCKEE THAT:**

1. The recitals above are true and correct.
2. Pursuant to California Vehicle Code Section 9250.7, the Town Council hereby agrees to continue for a period of 10 years the \$1 vehicle registration fee for the abatement, removal, and disposal of abandoned vehicles within the County of Nevada.
3. Collection of the \$1 registration fee shall continue through April 30, 2032.
