OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION AUTHORIZING EXECUTION OF THE MASTER CUSTOMER AGREEMENT WITH WATCHGUARD VIDEO, INC., TO PURCHASE BODY WORN CAMERAS, SOFTWARE LICENSES, AND ASSOCIATED NECESSARY EQUIPMENT, AND AUTHORIZING A BUDGET AMENDMENT TO FUND THE PURCHASE OF THE BODY WORN CAMERA SYSTEM. (4/5THS AFFIRMATIVE VOTE REQUIRED)

WHEREAS, law enforcement agencies' use of Body-Worn Cameras (BWC) has shown to be a promising practice that can improve capacity to gather evidence and improve safety of law enforcement officers and citizens; and

WHEREAS, On October 23, 2018 Resolution 18-507 accepted a grant in the amount of \$123,000 to be used for the acquisition of a Body Worn Camera System (BWC); and

WHEREAS, the Sheriff's Office developed, and issued a Request for Proposal for a BWC selecting WatchGuard Video, Inc as the successful bidder for the sale of the BWC in the amount of \$152,629 and;

WHEREAS the Sheriff's Office has completed all the conditions and necessary tasks accompanying the accepted Grant, is ready to move forward with the purchase of the Body Worn Camera System and will drawdown \$91,399.00 of Federal Grant Funding ; and

WHEREAS, the Sheriff's Office intends to utilize the BWC equipment for patrol, corrections, court holding, investigations, and animal control; and

WHEREAS, the three main objectives of the BWC Program are to provide for transparency and accountability; develop policies that provide for privacy and operational procedures; and implement the use of BWCs by the Sheriff's Office.

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the County of Nevada, State of California, that the purchase of the Body Worn Camera System from WatchGuard Video, Inc., in the amount of \$152,629 for a term to end twelve months after execution of the Agreement, be authorized and that the Chair of the Board of Supervisors be and is hereby authorized to execute the Agreement on behalf of the County of Nevada, authorizes the Purchasing Agent to execute all necessary documents and directs the Auditor-Controller to make the following adjustment to the Sheriff's FY 21-22 budget and release \$61,300.00 from Fund 1171:
