Grand Jury Purpose & Overview

- Investigate the operations of all county agencies, special districts, schools, and other entities that receive public money.
- Issues are chosen by the jurors based on citizen-initiated complaints and on the will of the jurors.
- The jury is required to annually inspect all public prisons in the county.
- The jury may investigate the efficiency of all local government activity, audit financial records, and review all public records.
- The deliberations are conducted in secrecy and jurors are sworn to maintain confidentiality for life.

Purpose & Overview, cont.

- Grand Jury Issues Reports include Findings and Recommendations
- Identified public agencies are required to respond to the findings per Penal Code Section 933.05 within 90 days
- Responses incorporate:
 - Examination of County records
 - Interviews
 - Review of CEO and County Counsel
 - Incorporate any requested department responses

Cannabis in Nevada County: A Growing Problem

2020-21 Grand Jury Report recommendations:

Need for Streamlining Permitting Process

- Processes have been and continue to be improved
 - (i.e. pre-application process, cannabis process improvement, 11/20 policy amendments, admin, process vs. conditional use permit, "Plants in Ground" Policy, 2-year land use compliance transition period, local equity study, etc.)
- Costs associated with H&S Code cannot be reduced or waived

Enforcement belongs with the Sheriff

- Nevada County Commercial Cannabis Ord. 2467 establishes cultivation as land-use violation
- Close partnership with Sheriff and Code Compliance where applicable



Response Summary

Cannabis in Nevada County: A Growing Problem

2020-21 Grand Jury Report recommendations:

- Need to re-evaluate fines and abatement
 - Fine/Fee Schedule remains consistent with State Code
 - Recent Board action removed \$25k cap on fines and penalties (Ord. 2491 on 4/27/21)



Response Summary

FLEET MAINTENANCE: Are citizen dollars being spent efficiently and effectively?

2020-21 Grand Jury Report recommendations:

- Need to develop strategic plans for implementing alternative fuel vehicles
 - Strategic Plans are in place and include converting NCSO Inceptors with hybrids and converting Transit Vehicles to electric by end of 2025
- Partner with incorporated jurisdictions
 - County partners and continues to explore opportunities where applicable (i.e. snow removal with Truckee and Placer County)
