**SUBJECT:** Resolution approving execution of Amendment No. 4 to the Contract with Glennah Trochet, M.D. pertaining to Interim Public Health Officer duties as required by the Nevada County Public Health Department during absences or unavailability of the County Public Health Officer to increase the maximum contract price from \$130,000 to \$250,535 (an increase of \$120,535) due to COVID-19-related work and emergency support, and revising Exhibit "B", Schedule of Charges and Payments to reflect the increase in the maximum contract price for the term of July 1, 2020 through June 30, 2022. (PESO3993) (RES. 20-473) (RES. 21-090)

**RECOMMENDATION:** Approve the attached Resolution.

**FUNDING:** Services are funded by state/federal dollars for Public Health administration and for COVID-19 support and response. Services were budgeted within the department's FY 2020-21 and FY 2021-22 budgets, and there are no County General Fund dollars required in the Agreement.

**BACKGROUND:** The Board of Supervisors of each county is required to appoint a physician that is in good standing and meets the qualifications of a county health officer as set forth in Health and Safety Code section 101005 to serve as the County's "Health Officer". Per Purchasing Contract No. PESO393, the renewal contract with Glennah Trochet, M.D. was approved on July 13, 2020 in the amount not to exceed \$14,500 and subsequently amended on October 15, 2020 to the maximum amount allowed within the Purchasing Agent's authority of \$50,000. On November 10, 2021, per Resolution 20-473, the Nevada County Board of Supervisors approved Amendment No. 2, increasing the maximum contract price to \$130,000, and amended again on April 13, 2021 per Resolution 21-090 to increase the hourly rate from \$145 per hour to \$150 per hour.

Under this agreement, Dr. Trochet provides back-up coverage services as the County's Public Health Officer and Registrar when the Health Officer, Dr. Alan Scott Kellerman, MD, is absent or otherwise

unavailable to carry out his/her duties as required by law, as well as additional COVID-19 emergency response and support.

It is recommended that the Board approve this Amendment No. 4 as this increase to the maximum contract price will help ensure that a qualified physician continues to be available to address a wide array of public health issues including infectious disease outbreaks, including the COVID-19 pandemic and responses to local emergency events on behalf of Nevada County.
