## TERMINATION AND RELEASE OF AGREEMENT - RIGHT OF ENTRY AND RIGHT OF WAY FOR DONATED RIGHTS OF WAY

This TERMINATION AND RELEASE OF AGREEMENT - RIGHT OF ENTRY AND RIGHT OF WAY FOR DONATED RIGHTS OF WAY (this "**Termination**") by and between Nevada City Cashin's Field, LP, a California limited partnership, as successor in title to Erickson Lumber Company (the "**Owner**") and Nevada County, a political subdivision of the State of California (the "**County**") is entered into as of this \_\_\_\_\_ day of \_\_\_\_\_\_\_, 2021.

WHEREAS, pursuant to that certain Agreement – Right of Entry and Right of Way for Donated Rights of Way (the "**Agreement**") dated May 27, 1980 and recorded with the Recorder's Office of the County of Nevada, California on June 3, 1980 as Instrument No. 80-15103, a right of entry to the land described on *Exhibit A* (attached hereto and made a part hereof) was granted to the County for the purposes of constructing a County road improvement (the "**Right of Entry**"); and

WHEREAS, further to the Agreement the County was also granted an exclusive option to accept donations of right of way of the land as described on <u>Exhibit B</u> (attached hereto and made a part hereof) for any and all County road purposes (the "**Option to Accept Right of Way**"); and

WHEREAS, the Owner and the County mutually desire to terminate the Right of Entry and the Option to Accept Right of Way as described on Exhibit A and Exhibit B.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Owner and the County agree as follows:

- 1. The Right of Entry is hereby terminated and no longer effective with respect to the land described on Exhibit A.
- 2. The Option to Accept Right of Way is hereby terminated and no longer effective with respect to the land described on Exhibit B.

- 3. The Agreement is hereby terminated, and both the Owner and the County are hereby released from any and all obligations thereunder.
- 4. This Termination may be executed in counterparts and all such counterparts shall constitute one single Termination.
