SUBJECT: **Resolution to Award the Contract for the 2021 Nevada County
Annual Striping Project 426639 to Central Striping Service, Inc.,
for a Total Amount of \$164,880.16 –All Districts**

RECOMMENDATION: Approve the attached resolution.

FUNDING: The project is budgeted in the fiscal year 2021/22 Road Maintenance budget. Funding is provided by Highway User Tax Account (HUTA) and Regional Surface Transportation Program (RSTP) funds. There is no impact to the County's General Fund and no budget amendment is needed.

BACKGROUND: On May 25, 2021, the Nevada County Board of Supervisors adopted Resolution No. 21-162 approving the plans, specifications and cost estimate for the subject project and instructed the Nevada County Purchasing Division to advertise for bids. The bids were opened on June 22, 2021, and are listed below:

* There were minor math errors in the second lowest bid which would not have altered the outcome of the bidding process. However, Traffic Limited did not include a required signature page (page 21) in their bid documents, therefore the bid is deemed non-responsive.

It is recommended that the contract be awarded to the low bidder, Central Striping Service, Inc., at the bid price of \$149,891.05 plus a 10% contingency of \$14,989.11 for a total of \$164,880.16.

This project involves striping of approximately 112 miles of County roads. Work is scheduled to begin in September 2021 and be completed within 35 working days as allowed for in the contract.
