We respectfully request your assistance to ensure that our public lands have adequate resources to ensure public safety and preservation of our natural resources. Specifically, we are requesting an increase staffing allocation of at least one Full-time Time Equivalent (FTE) law enforcement officer for both the United States Forest Service and Bureau of Land Management for federal public lands in the County of Nevada.

Nevada County, with a population of 100,000 residents, is receiving nearly 700,000 to 800,000 visitors annually to our various Federal and State forests and parks.
