

RESOLUTION No. 21-350

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF NEVADA

RESOLUTION REQUESTING CONSOLIDATION OF THE TRUCKEE FIRE PROTECTION DISTRICT SPECIAL TAX ELECTION WITH THE SEPTEMBER 14, 2021 CALIFORNIA GUBERNATORIAL RECALL ELECTION

WHEREAS, Elections Code section 10002 provides that a governing body of a district may request a county elections official to render election services, at a cost that shall be borne by the district, and that said election services shall be performed by the county elections official upon approval of the board of supervisors; and

WHEREAS, on May 11, 2021, the Board of Directors of the Truckee Fire Protection District (District), in Resolution No.02-2021, called a special all mailed ballot election to be held on August 31, 2021, on the question of whether the voters shall approve a special fire tax; and

WHEREAS, on June 28, 2021 the California State Legislature passed Senate Bill 152, which permits any special district that called for a special election to consolidate with the recall election, provided that (1) the special local election was called prior to June 15, 2021; (2) the original date on which the special local election was called is not more than 30 days before and not more than 30 days after the date of the gubernatorial recall election; and (3) the call to consolidate the special local election with the gubernatorial recall election is issued within four days from the date of the Lieutenant Governor's proclamation; and

WHEREAS, on July 1, 2021, the Lieutenant Governor of California issued a proclamation calling for the recall election of Governor Gavin Newsom on September 14, 2021; and

WHEREAS, on July 2, 2021, the Truckee Fire Protection District called an emergency meeting and signed Resolution No. 12-2021, amending their original resolution and requesting to consolidate the Special Fire District Election originally scheduled for August 31, 2021 with the California Gubernatorial Recall; and

WHEREAS, Resolution No. 12-2021 establishes that the Special Fire District Election meets all the elements necessary for the District to consolidate with the California Gubernatorial Recall Election; and

WHEREAS, the Truckee Fire Protection District, which includes both Nevada and Placer Counties, will also have this same Special Tax Election appear on ballots administered in Placer County; and

WHEREAS, the Truckee Fire Protection District shall reimburse the County for their prorated share of costs incurred by the County Elections official, in accordance with Elections Code section 10520, in addition to the labor already incurred prior to consolidation with the California Gubernatorial Recall Election.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Nevada, State of California, that the Nevada County Clerk-Recorder-Registrar of Voters is directed to consolidate the Truckee Fire Protection District Special Tax Election with the September 14, 2021 California Gubernatorial Recall Election and to bill the District for the cost of the election.
