BACKGROUND:

At the time of appointment, there were 2 vacancies and 7 positions available on the Penn Valley Municipal Advisory Council (MAC). These positions were advertised and posted for a minimum of ten days at the following places: the Board of Supervisors Chambers bulletin board, the Board of Supervisors office, Truckee Town Hall, the District V Board of Supervisors office in Truckee, and on the County website.

Julia Stidham and Tom Harnett have been appointed by Sue Hoek, District IV Supervisor, for appointments to the Penn Valley Municipal Advisory Council to fill unexpired two year terms ending June 30, 2023. Julia submitted an application for appointment on July 13, 2021, and Tom submitted an application for appointment on July 14, 2021.

Incumbent members Richard Nolle, Bob Winters, Douglas Moon, Ryan Everson, Rob Tribble and Teresa Dietrich applied for reappointment. Supervisor Hoek proceeded with the reappointments and their new terms began July 1, 2021 and will end June 30, 2023.
