Dear members of our Board of Supervisors,

I cannot attend the meeting on Tuesday, September 14, but would appreciate it if you could read my letter during the public comment period.

My name is Barbara Larsen and I have lived in Nevada County for 43 years. Over the past 35 years I have worked in the field of dementia care in a variety of settings as a family and education consultant. I have been welcomed into many of your homes to provide assessments, help navigate the many resources we have in our county, and walked hand in hand with you in support of having to deal with a loved one who has Alzheimer's disease or a relate dementia.

It doesn't matter what side of the political or philosophy spectrum you attune yourself with. Whether it be far right, far left or somewhere in between. It doesn't matter whether you have a statue of Jesus, a confederate flag, a sign for Trump or Biden....I show up at your door step as an advocate and partner to make sure you receive the best services to foster your independence.
