RESOLUTION ACCEPTING THE FY 2020 COMMUNITY POWER RESILIENCY (CPR) PROGRAM ALLOCATION FOR FISCAL YEAR 2020-2021 FROM THE CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES TO PREPARE FOR AND RESPOND TO PUBLIC SAFETY POWER SHUTOFF (PSPS) EVENTS IN THE AMOUNT OF \$187,757 FOR USE DURING THE PERIOD JULY 1, 2020 THROUGH MARCH 31, 2022

WHEREAS, on October 27, 2019, Governor Gavin Newsome Proclaimed a State of Emergency to exist in California due to extremely dangerous fire weather resulting in the deenergization of power lines known as Public Safety Power Shutoffs; and

WHEREAS, Resolution 19-588 ratified a Local Emergency, declared a further emergency due to recurrent PSPS events, and designated the Director of Emergency Services as the authorized representative of the County of Nevada for the purpose of receipt, processing, and coordination of all inquiries and requirements necessary to obtain available State and Federal assistance; and

WHEREAS, the California Governor's Office of Emergency Services (Cal OES) made available \$10 million in State General funds for the 2019-20 PSPS Resiliency program to prepare for and respond to PSPS events; and


WHEREAS, the Director of Emergency Services applied for the Grant and on October 25, 2019, the County was awarded an allocation of \$375,514 for the period July 1, 2019 to October 31, 2021. The Office of Emergency Services requested and extension through March 31, 2022; and

WHEREAS, the FY 2020 CPR Allocation for FY 20-2021 was made available and an application was submitted and awarded to Nevada County by Cal OES on October 2, 2020, in the amount of \$187,757; and

WHEREAS, the Local Emergency Declaration that delegated authority to the Director of Emergency Services to accept the grant award has expired.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Nevada hereby directs:

- 1. That the County of Nevada accept the grant allocation in the amount of \$187,757 for the grant period July 1, 2020 through March 31, 2022.
- 2. That the Director of Emergency Services, County Executive Officer, and Assistant County Executive Officer are authorized to fulfill the requirements of the FY 2020 Community Power Resiliency Program.
- 3. That the Auditor-Controller deposit grant funding in the amount of \$187,757 into the Emergency Management Budget 0101-20702-414-1000/445090.
