

ACTION TAKEN: Chair Miller introduced the agenda item and Panos Kokkas, Director of Public Works, reviewed the staff report and provided a PowerPoint presentation regarding the proposed Ordinance adding parking prohibitions on Old Downieville Highway and Champion Road. Director Kokkas reported on parking issues on the narrow road, which makes it difficult and dangerous for routine and emergency traffic to pass through safely. A neighborhood meeting was held regarding the issues affecting Old Downieville Highway and Champion Road. During that meeting, health and safety concerns were raised, including the hazard of wildfires started by campers, lack of public restrooms, pollution of Deer Creek by campers bathing and washing laundry in it, littering, and safety issues caused by parked vehicles impeding access for residents and emergency responders. The amendment to the Ordinance is needed to enable enforcement of no overnight camping to address these issues.

Director Kokkas responded to Board questioning and discussion ensued.

Chair Miller provided an opportunity for public comment, and comments were received. Chair Miller closed public comment.

**MOTION: Motion made by Supervisor Hall, seconded by Supervisor Bullock, to introduce and waive further reading of the Ordinance. On a roll call vote, the motion passed unanimously.**

**\*DEPARTMENT HEAD MATTER:****Building Director: Craig Griesbach**

21. [SR 21-0569](#) Resolution adopting the Nevada County Cannabis Equity Assessment and Cannabis Local Equity Program Manual, and creating the Nevada County Cannabis Local Equity Program pursuant to the California Cannabis Equity Act of 2018. (Supervisor Dan Miller - No)

**Adopted.**

ACTION TAKEN: Following a short break, Chair Miller called the meeting back into order. Craig Griesbach, Building Director, reviewed the staff report and provided a PowerPoint presentation "Nevada County Cannabis Equity Assessment and Local Equity Program," in coordination with Dr. Dominic Corva, California Center for Rural Policy at Humboldt State University, and Jeff Merriman, Code and Cannabis Enforcement Program Manager. Dr. Corva is one of the primary authors in the development of the Assessment and Programmatic documents that will be reviewed during the presentation. Director Griesbach reviewed his Department's efforts to improve the County's cannabis programs, including improve staffing and capacity overall, along with opportunities to increase their capacity in the coming months and years. Staff is implementing tools, such as the unmanned aircraft system program, establishing interagency Memorandums of Understanding (MOUs), creating policies for administrative abatements to improve enforcement effectiveness, and they are actively working on an annual Board Objective of investigating cannabis licensing types. Director Griesbach's Team is reviewing the County Ordinance to reduce barriers to entry while protecting neighborhoods. Staff is actively reviewing funding opportunities to help fund the permitting programs and have identified several grants that they will be applying for in the coming year to support these efforts. Additionally they are collaborating with other rural jurisdictions that have similar programs, to support Nevada County's long-standing, small, legacy cannabis farmers. Director Griesbach reviewed Assembly Bill 97 (AB 97), the California Cannabis Equity Act, which provides an established agreement to administer a Cannabis Equity Grants Program, which supports the intent of Proposition 64 and the Adult Use of Marijuana Act, and is aimed at reducing barriers to entry for regulated cannabis, while reducing the illicit cannabis market.

Dr. Corva provided background and an overview of the Project, which provides support for local, long-standing cannabis growers. The Equity Assessment and Local Equity Program reduces barriers to entry for regulated cannabis farmers. Nevada County has a significant legacy population with expertise on cannabis cultivation, breeding, and medical product formulation that struggle with transition to regulated markets. Dr. Corvas reviewed barriers to entry, which include: financial costs; limited banking services; and permitting processes.

Program Manager Merriman reported that over 40 interviews and meetings were held with elected officials, and local government departments, and noted that several counties and cities are developing or have already established equity programs. The Equity Program provides support for small legacy cannabis farmers, supports enforcement efforts, and provides assistance for compassionate/medicinal use programs.

Director Griesbach reviewed next steps, including: ongoing evaluation of the program; applications for Type 2 Grant funding; local funding contributions; build-out of program logistics; and continued partnerships with community stakeholders, other rural jurisdictions, and state cannabis equity program stakeholders.

Staff recommended the Board adopt the proposed resolution creating a Cannabis Local Equity Program, and the Nevada County Equity Assessment and Local Equity Program Manual.

Board questioning ensued.

Chair Miller provided an opportunity for public comment, and comments were received. Chair Miller closed public comment.

Board discussion ensued.

Supervisor Hall shared her support of the Program and the cultivators who have come into compliance.

Supervisor Bullock shared his support of the Program although admitted to being an initial critic of cannabis. Since that time, Supervisor Bullock has come to understand that cannabis is a viable and important part of the local economy. The Supervisor did have concerns regarding the high use of cannabis among teens in Nevada County, and therefore urged that revenue from the sale of cannabis be directed to educational programs that assist in the prevention of substance abuse among the County's youth.

Supervisor Scofield shared concerns that the report appeared to be one-sided, and did not include significant issues that were experienced within the County's neighborhoods and communities. Supervisor Scofield would approve the Program because it supports small legacy farmers; although the impacts on the community are real and there is still a need for ongoing protection of the neighborhoods.

Supervisor Hoek agreed with some of Supervisor Scofield's comments and acknowledged there were challenges. Supervisor Hoek carefully reviewed the Local Equity Program and could see how it would provide support for the community's local, legacy farmers.

Chair Miller reiterated Supervisor Scofield's comments, and he shared many of his own concerns regarding language in the report, and the likelihood of growers coming into compliance.

Board discussion continued.

**MOTION:** Motion made by Supervisor Hall, and seconded by Supervisor Bullock, to adopt Resolution 21-431, adopting the Nevada County Cannabis Equity Assessment and Cannabis Local Equity Program Manual, and creating the Nevada County Cannabis Local Equity Program. On a roll call vote, the motion passed as follows: Supervisors Hall, Scofield, Hoek, and Bullock - Aye; Supervisor Miller - No.
