Dear Members of the Board of Supervisors,

Over my 43 years of living in Nevada County I have spent 36 of these years as a elder care advocate and working in the field of dementia care in a variety of settings as a director, educator, family consultant, founder of the Elder Care Providers' Coalition, etc. Of course, Ed, you have known me since the 1980s when I was the director of the Adult Social Day Care Center before it became the Lutz Adult Day Care. How many times over the years have I spoken at the Board's meetings to support in maintaining the independence of our elders and family caregivers.....and, at one point in time three of the board members and many county employees where clients of mine through Del Oro Caregiver Resource Center.

During the last Board meeting on September 28 I watched the majority of citizens who spoke during the Public Comment portion that are against following the state and county mandates given more time than the citizens who believe in health and well being of the common good in our community. When the five letters, including mine, in support of Dr. Scott Kellermann were not read because of a lack of time, I didn't understand how the protocol to allow citizens to speak in support of our heroic health care professional would be undermind.

Are you really not aware of the abuse that is happening in our community to teachers, health provider's, county public health employees, etc? Let me give you an example: About a month ago I had my biannual mammogram and bone density test at a local clinic. After my mammogram I was brought into a room for my bone density scan. After the procedure I asked the

technician, who by the way was a kind, compassionate woman if she had experienced any abuse or acting out behavior from any patients. She immediately told me that within the past week a woman came into the clinic for a bone density scan. Of course, she had to have made an appointment. When the woman walked in without a mask she was asked by the receptionist to please put on a mask in following with the health mandate. The woman did put on a mask and was escorted to the room to have her test done. The technician said the woman wasn't very friendly, but she proceeded with the exam. Upon completing the scan the woman got off the table and while facing the technician through her mask off at the technician and screamed, "You fucking, Nazi, bitch!" I asked the tech if she called the police because this was not only abuse, but an assault. She said that no she didn't, but stated the woman could no longer be a patient at the clinic. I said, but nobody knows that!! What was this woman thinking?

The patient was using the services of the clinic to determine if she had osteoporosis and use the information to possibly prevent bone loss through medication and or other remedies.

Regarding another issue of how the unvaccinated are impacting the well being of their neighbors, my husband's cardiologist prescribed a procedure that had to be done at our local hospital. At that time there were 30 cases of people being cared for at SNMH (29 unvaccinated, 1 vaccinated). My husband was not allowed, along with how many people(?) to have a procedure that would possibly save his life and be preventative in nature because of someone's 'opinion' that the virus is a hoax? Finally, through been vigilant he was able to have the procedure.

Back to the beginning of my letter: So you are giving voice to those who could care less about the well being of our neighbors in the guise of fairness? Where is your moral/ethical consciousness? Just like the technician mentioned at the clinic regarding the woman's abusive behavior, "She can no longer be a patient here." Again, my reply was, but nobody knows that! By not reading the letters of support for Dr. Kellermann and stating that 'we' have read them, meaning you the Board members, my comment is, but nobody in our community is being made aware of those possible important comments and experiences of the people who support the mandated protocols. The people who are acting out and given a platform are being rewarded, and because they don't believe that the virus is contagious and can harm others they feel not at risk by showing up at the board chambers. However, many of the citizens I have worked with are vulnerable elders and family caregivers who cannot risk coming to the chambers and afraid to show up because of how the ignorant and self-servicing folks have been given license to threaten and abuse those who do show up.

Where is your discernment? Approximately, 65% of our citizens have been vaccinated. If this was an election it would be a land slide....no debate, no opinions!! If the issue was, does second hand smoke cause cancer, would you really allow people to stand on the platform and say, "Well, my opinion is second hand smoke does not cause cancer." Well, my dear science and facts say it does." No discussion, no opinion.

It appears that the very officials who are suppose to protect our safety and

well being are allowing these bullies to win. The many speakers who you are allowing to speak are the very ones who are bellying our vulnerable citizens. This is not fair game. I am asking you to step up and see who you are rewarding, because it's not the citizens who are following the mandates that are acting out and threatening the health and well being of our beloved community members.

I would like this added to the record for todays meeting.

Now I stand here amongst my fellow man in the this great nation, and you do not. We the people are here to share, discourse, bring concern and resolution, and our leaders are not present. We the people are leading fearlessly. Where are our leaders? I have seen some of you comment on social media that many of us that show up are loud, angry, and spit conspiracies. Why are you trying to fool the public? I have also see you comment that we are a small few. Well hepatitis b was discovered in 1965, and it's first licensed use was in 1981. Rotavirus first discovered in 1973 and it's first approved for use vaccine given in 1998. Diphtheria was first identified in 1883, and a vaccine first developed in 1920s but not widely used until 1930s. Pertussis first identified in early 1900s while the vaccine developed in the 1930s, it was not largely used until 1940s. Polio was first discovered in 1908 and while the vaccine was developed in 1950, it was not administered to children until 1954. Pneumococcal conjugate identified in early 1900s; first licensed vaccine in 2000. Measles and Rubella have been around for centuries and the first discovery of Mumps was in 1934; the MMR vaccine licensed in 1971. Hep A identified 1979; licensed vaccine in 1995. Covid-19 virus "first identified" in 2019; vaccine distributed, unlicensed, 2020. It is not unreasonable to want to wait. It is CERTAINLY not unreasonable to want your kids to wait.

The "Governor" wants to force unforeseen consequences on our children in order for them to participate in their right to school; an institution that our children, belonging to tax paying citizens, have the right to attend. Now is the time for you to be fearless. To take a stand for our community, and for our children which are the future of this community. You were elected by We The (Fearless) People to lead us in battles such as this one, and if you do not prove yourselves to be leaders as such, then we will find new ones. This battle is NOT amongst the few. We are many. Please do the right thing.
