He reviewed the steps the County has taken to be prepared for evacuation shelters and cooling centers that may be needed in an emergency. Captain Pettitt reviewed the Cal OES (California Office of Emergency Services) and FEMA (Federal Emergency Management Agency) grants the County applied for and he detailed the initiative programs showing how the funding will be used. He reviewed the current enforcement program for the County's Hazardous Vegetation Ordinance and outlined the Ponderosa West Grass Valley Defence Zone Project.

Board discussion and questioning ensued.

Chairman Anderson provided an opportunity for public comment. The following members of the public provided comments: Mr. Matthew Coulter, District I resident; Mr. Lee French, District II resident; and Ms. Eve Diamond, District IV resident. There being no further public comment, Chairman Anderson closed the opportunity for public comment.

He clarified the distinctions of broadband development, explaining that the last-mile provides for end-user connection to a local network provider. Mr. Monaghan gave an overview and history of broadband development in Nevada County and reviewed the challenges the County faces to increase service. Staff is proposing to direct the County's reserved Economic Development Infrastructure funds in the total amount of \$250,000; \$25,000 for a grant solicitation and administration contract with SBC, and \$225,000 for the actual project award.

Mr. Thorsby reviewed the Scope of Work for the contract with SBC, and Ms. York reviewed the efforts SBC has made towards leveraging broadband funds and access in Nevada, Placer, El Dorado, Sierra and eastern Alpine counties.

Board questioning and discussion ensued.

Ms. Alison Lehman, County Executive Officer, clarified the RFP (Request for Proposal) process, stressing that this project will not delay or impact money currently set aside for other projects that are additional Board priority projects.

Chairman Anderson provided an opportunity for public comment. Mr. Blinder commented regarding how significant the arts are to the economy of Nevada County, the contribution the arts make to the vibrant culture of the County, and the attraction it creates for new business to come to the County.
