**24.** SR 19-1056 Report from Gold Country Community Services (GCCS): Food Insecurity within Nevada County. (Janeth Marroletti, Executive Director, GCCS)

ACTION TAKEN: Ms. Janeth Marroletti, Executive Director, Gold County Community Services (GCCS), provided a PowerPoint presentation regarding Food Insecurity in Nevada County. She requested assistance from the Board of Supervisors to increase food resources; establish a Senior Center; include homebound seniors in emergency plans; enhance collaboration for services; evaluate options for transportation; and support workforce development.

Board questioning and discussion ensued.

Chairman Anderson provided an opportunity for public comment and the following members of the public provided comments: Ms. Barbara Larson, Senior Advocate and District V resident; Mr. Phil Alonso, Executive Director, Interfaith Food Ministry and District II resident; Ms. Karen Chileski, Meals on Wheels volunteer and District III resident; Mr. Gabriel Lenhart, GCCS Board member, and District II resident; Ms. Pinkie Zalkin, District I resident; Ms. Theresa Haleen, Chair of the Elder Care Providers Coalition; and Ms. Maureen Gerecke, FREED employee and District III resident.

There being no further members of the public wanting to speak, Chairman Anderson closed the opportunity for public comment.

23. SR 19-0956 Acceptance of the Nevada County Veterans Services Office Fiscal Year 2019/20 informational report and presentation. (Veterans Services) Accepted.

ACTION TAKEN: Sargeant David West, Veterans Services Officer provided a PowerPoint presentation regarding the services his office provides to the 8,585 Veterans that live in Nevada County. He reported that only 24.1% of the Veteran population living within the County is receiving Veterans Administration (VA) benefits, which is below state average. Sargeant West stressed that his goal is to reach out to Nevada County's Veterans to ensure that all eligible Veterans are receiving services, and he outlined some of the methods of outreach his office is working on.

Board questioning and discussion ensued.

Chairman Anderson provided an opportunity for public comment, and Mr. Wade Laughter, District I resident, provided comments. There being no further members of the public wishing to speak, Chairman Anderson closed the opportunity for public comment.

## SCHEDULED ITEM: 10:30 A.M. Building Director, Craig Griesbach

**26.** SR 19-0977

Public hearing to consider the appeal filed by Mr. Scott Merritt regarding the Nevada County Building and Accessibility Standards Board of Appeals notice of determination dated September 5, 2019, regarding Section R317.1.3 of the 2016 California Residential Code requiring all horizontal and vertical structural members of decks exposed to the weather to be of materials that are naturally resistant to decay or pressure treated. The project is for the construction of a 2 story structure with main level workshop (1,567 sq. ft.), upper level single family residence (1,822 sq. ft.), and deck (1,730 sq.ft.). (Dist. I)

Resolution denying the appeal filed by Mr. Scott Merritt regarding the Building and Accessibility Standards Board of Appeal's August 29, 2019 decision to uphold the determination of the Building Official regarding Building Permit 181444 at 16887 Champion Road, Nevada City (APN 004-151-008), regarding Section R317.1.3 of the 2016 California Residential Code requiring all horizontal and vertical structural members of decks exposed to the weather to be of materials that are naturally resistant to decay or pressure treated. (Supervisors Hall, Scofield and Miller - Aye; Supervisor Hoek and Anderson - No)

ACTION TAKEN: Mr. Craig Griesbach, Building Director, reviewed the staff report and provided a PowerPoint presentation, regarding the appeal filed by Mr. Scott Merritt of the Nevada County Building and Accessibility Standards Board of Appeals notice of determination requiring all horizontal and vertical structural members of decks exposed to the weather to be of materials that are naturally resistant to decay or pressure treated. He explained that Mr. Merritt's deck was built from materials that are not pressure treated or naturally resistant to decay. Mr. Griesbach reviewed the Board of Appeal process. He concluded his report and recommended the Board uphold the decision of the Appeals Board.

Board questioning and discussion ensued.

Mr. Scott Merritt, Appellant, provided his presentation regarding the requirement to construct his deck with pressure treated or naturally resistant to decay building product. He stressed that it was not clear to him as to which of the building codes applied to the construction; he mentioned that the first Building Inspector did not mention the issues regarding the deck construction. It was not until a second inspection was completed that the Inspector noticed issues with the deck construction. Mr. Merritt stressed that the way the deck is built is far superior to the requirements of the Building Code, and he suggested that there would be more damage done to the deck if it were torn apart. Mr. Merritt wondered why a second inspection was necessary. He suggested the cost to make the required changes to the deck could be \$40,000. He concluded his presentation and requested the Board uphold his appeal.

Mr. Griesbach clarified the building and inspection process.

Board questioning ensued.

Chairman Anderson opened the public hearing for public comment. There being no public comment, Chairman Anderson closed the opportunity for public comment.

Mr. Merritt provided his summation, requesting the Board uphold his appeal. He again stressed that local pest companies suggested that the way his deck is built is far superior than it would be if he used the construction materials required and he requested it be considered more than adequate. He concluded his summation.

Mr. Griesbach provided staff's summation. He noted that this rule has been on the books for a very long time. He agreed that it would be difficult to change, as well as costly, but they consistently follow the California Building Code.

Mr. Griesbach responded to Board questioning and discussion continued.

MOTION: Motion made by Supervisor Miller, seconded by Supervisor Scofield, to adopt Resolution 19-607. On a roll call vote the motion passed as follows: (in roll call order) Ayes: Supervisors Scofield, Miller, and Hall. Noes: Supervisors Hoek and Anderson.

(Introduce/Waive further reading) An Ordinance amending Chapter V of the Land Use and Development Code of the County of Nevada, adopting the 2019 California Building Standards, and Local Amendments thereto; and adoption of express findings of reasonable necessity to changes and modifications to the California Building Standards Code based on local climatic, geological, or topographical conditions.

First reading held.

ACTION TAKEN: Mr. Craig Griesbach, Building Director, reviewed the staff report regarding the Ordinance proposing to amend Chapter V of the Land Use and Development Code of the County of Nevada, adopting the 2019 California Building Standards, and local amendments thereto: and adoption of express findings of reasonable necessity for changes and modifications to the California Building Standards Code based on local climatic, geological, or topographical conditions.

He concluded his presentation, and responded to Board questioning.

Calfire Fire Captain/Nevada County Fire Planner, Matt Furtado, and Fire Chief Terry McMahon, Nevada County Consolidated Fire Protection District, responded to Board questions regarding the California Fire Code.

Chairman Anderson opened the public hearing for public comment, and the following members of the public provided comments: Mr. Wayne Littlesee, Nevada County resident; Ms. Joey Jordan, District IV resident; Ms. Barbara Bashall, Executive Director, Nevada County Contractor's Association; Ms. Sheri Murray, Co-Owner Statewide Homes and District I resident; Mr. Tim VanWagner, District I resident; Ms. Diana Gamzon, Executive Director, Nevada County Cannabis Alliance and District I resident; Mr. Denis Kutch, District V resident; Mr. Wade Laughter, District I resident; and Mr. Sky Rutherford, District III resident.

There being no further public comment, Chairman Anderson closed the opportunity for the public to provide input.

Mr. Griesbach responded to questions asked by members of the public.

Mr. Griesbach reported that all Counties and Cities are required to adopt the California Building Codes. Codes that are suggested for Nevada County in particular can be revised. He explained that it would be a downside if they were not adopted, because staff would not be able to address the regulations in the field. Mr. Griesbach stressed that it is up to the Board as to whether or not they decide to adopt the California Building Codes at this time and review Nevada County specific revisions at a later date.

Mr. Griesbach responded to Board questioning.

Supervisor Miller was concerned about insurance affordability for a manufactured home without sprinklers, and requested more research on the issue prior to adoption. Supervisor Hoek was in support of implementing sprinkler systems as a means to ensure the safety of firefighters, although both Supervisors Hall and Hoek shared concerns about implementing sprinkler systems due to increased costs and regulation. Supervisor Scofield did not support adding sprinkler systems into manufactured homes if it they are not required by California Building Code Standards.

Supervisors Scofield, Hall and Hoek agreed with the 5-foot space between hoop houses.

Ms. Sheri Murray reported that she has heard from one insurance company that discounts can be provided by insurance companies for manufactured homes if sprinklers are installed, although she has also been told that it does not affect the insurability of a manufactured home.
