ACTION TAKEN: Superintendent Scott Lay shared a short video introducing Youth Art Month, and he provided a PowerPoint presentation. Superintendent Lay reported that eight of the Nevada County's nine Schools Districts are open for in-person learning, as well as two of the County's five Charter Schools. Five art disciplines are taught: Music; Theatre; Dance; Visual Arts; and Media Arts. The Office of the Superintendent of Schools has partnered with the Nevada County Arts Council, and together they developed a strategic Arts Plan for the County's students. There is proven recognition that Arts in education teaches 21st century skills like critical thinking, collaboration, communication, and community engagement and empathy. Superintendent Lay reported that the Arts are integrated across subject areas in the Common Core State Standards, and he stressed the importance of community partnerships, which provides Art opportunities for Nevada County's children.

Board discussion and questioning ensued.

## **INDIVIDUAL BOARD MEMBER ITEMS:**

18. SR 21-0133 Presentation from Town of Truckee Mayor Anna Klovstad and Truckee Town Manager Jennifer Callaway on the Town of Truckee 2021 priorities Presentation provided.

ACTION TAKEN: District V Supervisor Bullock reported that he recently had the opportunity to provide a presentation regarding Nevada County's priorities for 2021 during a recent Truckee Town Council meeting along with Ms. Alison Lehman, County Executive Officer, and he was excited to introduce Truckee Town Mayor Anna Klovstad and Truckee Town Manager Jennifer Callaway to hear about the Town's priorities.

Mayor Klovstad and Town Manager Callaway provided a report regarding the Town of Truckee's priorities for 2021. Mayor Klovstad spoke of the challenges related to leading the Truckee community through the COVID-19 pandemic. It became apparent that small businesses in Truckee needed financial support, and she thanked the Board for providing CARES Act funding to the small businesses to get the through the winter months, and for starting the Nevada County Relief Fund. Mayor Klovstad provided a video highlighting Truckee's partnership with Nevada County.

Ms. Callaway provided a PowerPoint presentation, and reported on the Town of Truckee's priorities for 2021, which closely coincide with the County's priorities. The Town's core services include Police and Animal Services, Community Development, Public Works and Engineering, Town Manager, Town Attorney, and Town Clerk offices, as well as the Keep Truckee Green Program (Waste and Recycling). Truckee's yearly budget is \$57 million per year, and their primary revenue source is provided through property taxes. The Town Council's Priorities for 2021 include: 1) Development of Workforce Housing; 2) Reduction in greenhouse Gas Emissions and Environmental Sustainability; 3) Enhanced Communications and Public Outreach; 4) Investment in Key Infrastructure and Community Connectivity; and 6) Enhancement of Partnerships and Investment in Wildfire Mitigation. Ms. Callaway noted that the County's Objectives for 2021 coincide with Truckee's Priorities, which creates an opportunity for a strong collaboration between the County and Truckee.

Mayor Klovstad concluded their presentation and Board questioning ensued. Chair Miller thanked Mayor Klovstad and Ms. Callaway for the presentation.

Resolution approving a donation of Zone Based Evacuation Planning Services from Zonehaven valued at \$84,270, for a term of December 28, 2020 through December 28, 2022. (Emergency Services)

ACTION TAKEN: Sheriff Lieutenant Bob Jakobs provided a PowerPoint presentation regarding the donation of Zone Based Evacuation Planning services from Zonehaven, valued at \$84,720.

Lt. Jakobs reported that zone based evacuation planning breaks counties and cities into manageable geographic evacuation zones based on topography, roadway architecture, egress and ingress routes in and out of neighborhoods, and population. Predefined evacuation zones enable emergency management personnel to eliminate unnecessary delays by establishing geographic boundaries, and allows incident managers to make more informed decisions. When individuals are aware of the zone they are residing in, they will be less likely to be confused as to whether they are under an evacuation order. Additionally, the evacuation zones can be pre-loaded into the County's Code Red Emergency Alert System.

Lt. Jakobs reported that Zonehaven, a private software developer, has awarded their Evacuation Management Platform to Nevada County for use during a period of two years. The County will implement a 'Know Your Zone' public awareness campaign, to educate the public of the zone they reside in. If after the two-year period the County decides not to continue partnering with Zonehaven, the County has been guaranteed the ability to retain the work that has already been put into the local zone development. Nevada County's Office of Emergency Services and Geographic Information Systems will continue the effort with the tools at their disposal. Lt. Jakobs requested that Board accept the donation from Zonehaven.

Board questioning and discussion ensued.
