Residential and Commercial Arts and and construction. Superintendent McFadden reported on current and future projects happening throughout the District provided by the Measure B Bond Program. Superintendent McFadden reported that the District has received a donation of an 86-acre ranch off McCourtney Road. Plans are under discussion to offer a hands-hand learning program at this location. Linda Melugin reported on the District's student scholarship opportunities for continuing education. They looked forward to returning to school next year.

Supervisors Hall and Scofield met with staff to review the requested changes, which include revisions to the definition of "Responsible Party" to mirror the definition of "Violator" and the return of the term "reasonably" back into the Ordinance, to clarify what determines that a Code Violation exists.

Supervisors Hall and Scofield were on the Ad Hoc Committee to review revisions, and they were both in agreement that the revisions made the changes requested by the Board when it was first introduced in March.

Administrative Analyst Tamo reported that the proposed contract aligns with the Board's Objective regarding wildfire mitigation, and encourages County residents to harden their properties against wildfire in both Eastern and Western County.

Jenn Tamo and Jamie Jones, Executive Director, Fire Safe Council, responded to the Board's questions, and discussion ensued. Supervisor Hall heard that Fire Safe Council will be distributing the green waste as mulch, so invasive plants, such as blackberry vines and scotch broom, will not be accepted.
